This Indenture, made on the Twenty first day of December in the year of our Lord one Thousand Eight Hundred and Seventy-five, Between L^d Julian, A N Routh and wife Mary M Routh of the County of Randolph and State of North Carolina on the one part and Tobias L Julian, Solomon^r Redding and Isaac F Julian, Trustees of the Religious Society of Methodist Protestants on the other part

Witnesseth, that the said L^d Julian, A N Routh and wife Mary M Routh for and in consideration of the sum of ten dollars to them in hand paid at the time of covenanting these presents, the receipt whereof is hereby acknowledged, hath bargained, sold, aliened and conveyed and by these presents doth bargain sell alien and deliver, unto the said Tobias L Julian, Solomon T. Redding and Isaac F Julian Trustees as aforesaid Two acres of land on the waters of Pole Cat, Lying and being in the County aforesaid to be known by the name of Bethany and bounded as follow

Beginning at a Stone Tobias L Julians line, thence East on said line Two Chains and Fifty Links to a stone. Thence North Seven Chains and Fifty Links to Black Oak Thence West Two Chains and Fifty Links to a stone. Thence South Seven Chains and Fifty Links to the Beginning, containing Two acres more or less together with all the premises and all and singular the tenements hereditaments woods ways waters mines, minerals and improvements thereunto belonging or in any wise appertaining to have and to hold to the said Tobias L Julian, Solomon T. Redding and Isaac F Julian Trustees as aforesaid and their successors in office in trust for and to the Sole use and benefit of the said Religious Society of Protestants forever and the said L^d Julian, A N Routh and wife Mary M. Routh for themselves their heirs Executors and Administrators will warrant and forever defend the above named land premises free from the lawful claims of any and all persons whatever, and that they the said L^d Julian A N Routh and wife Mary M Routh is now at the time of covenanting these presents seized and possessed of a good sure and legal right to convey the said land and that they have full power and lawful authority to convey the same in manor and form aforesaid unto the said Tobias L Julian, Solomon T. Redding and Isaac F Julian, Trustees as aforesaid.
